CALVERT CITY - Assistant Chief Terry Culver suffered a cardiac related event while responding to an emergency call on November 12, 2015. He was resuscitated but never regained consciousness.

Assistant Chief Culver passed away on November 24, 2015 at the age of 65. Terry served as a firefighter for more than 38 years and was assistant chief the last 15 years. He is survived by his two sons, Jason and Erik Culver, a brother Garry Culver, and six grandchildren.

Terry was laid to rest at Brooks Chapel Cemetery in Dexter Kentucky. The KFA was honored to participate in Terry's funeral.

We continue to have civilian fire deaths across the Commonwealth. With the very cold weather upon us, it is important to keep the citizens we serve educated on heating device use and the proper installation and maintenance of smoke detectors/CO detectors.

The dues statements went out in October of 2015 and if you overlooked paying your dues, please take that into consideration. One of the principal benefits we supply is our lobbyists (Howdy Kurtsinger and Steve Rath) working with the Legislators in Frankfort. With the Legislation session upon us, it is very important we stay vigilant with the fire service issues. Our two biggest issues this year are the Cancer Presumption and State Aid/Incentive Pay. Howdy and Steve will monitor the progress of each of these two bills along with other issues that may come up and keep us posted on WHEN we need to contact our Legislators. YOUR Legislators need to hear YOUR voice, and they will listen to their voters!

LEXINGTON - On November 18, 2015 the Legislative Committee had a meeting in Lexington at the State Fire Commission Offices. In attendance was the Fire Commission, Kentucky Firefighters Association, Kentucky Fire Chiefs Association, Kentucky Professional Firefighters Association, and the Jefferson County Trustees and Fire Chiefs Association. All groups discussed their legislative goals and agreed to support each other in Frankfort during the 2016 Kentucky Legislative session.

It was voted on during the 2015 KFA Conference in Paducah to support the following resolutions;

- KFA 1-2015** Legislation reverting the tax/fee hearings to being held at the main fire station of the Fire District as in years past.
- KFA 2-2015** Legislation to support a change in KRS Chapter 75.260 to increase the compensation of board members.
- KFA 3-2015** Legislation to support and increase in State Aid and Incentive Pay, and to continue to support the cancer presumption bill.
- KFA 4-3015** Support for the Commissioner of the Department of Agriculture to have a seat on the Fire Commission. The KFA legislative committee voted to send this to the Fire Commission for their action and not to place in legislation.
- KFA 5-2015** Same as above #3 support for State Aid increase.
- KFA 6-2015** Changes in the pension in many areas with the support of the KPFF.

Fireman without borders is a program that helps fire departments that do not have the opportunity or financial support to provide their firefighters with proper PPE. David Torres is working with this program to help fire departments across the border receive much needed equipment. “The departments I’m talking about are those that don’t have the opportunity to apply for grants to receive equipment”, said Torres.

Torres is asking for departments to donate any surplus gear or even damaged equipment. “I’m willing to sign any and all paperwork required by donating departments to accept these items”, Torres said. Items donated will be fixed as best as possible and then provided to the Colima, Mexico Volunteer Fire Department. “Everything they currently have is donated, but it is reaching its shelf life, and will soon be useless. Anything you are willing to give will be great since they have nothing”, said Torres.

Testing within the Kentucky Accredited Certification Program

All Kentucky firefighter certifications that carry IFSAC accredited credentials, require the candidate to complete both a written examination and a skill competency evaluation. The written portion of the process is usually arranged by the lead instructor of class-based certification, such as Level 1 Fire Instructor. Written exams are also available through the offices of State Fire Rescue Training, by contacting the Area Coordinator of the office nearest you. You can locate that information on our website www.kyfa.org

Additionally, for your convenience the Kentucky Fire Commission offers all written exams at its Headquarters once per month, **118 James Court, Lexington, KY**. Typically, it is the third Monday of each month, adjusted for holidays.

Written exams require 70% to achieve a passing grade. Exams are mostly multiple choice questions, with a few True/False and Matching questions. Exams carry a completion time limit.

Skills testing for FF 1 and 2 is a random sampling of all possible skills in each certification level. There are multiple skill possibilities at each station, however the candidate will only be required to perform 1 skill at each station. 2015 policy changes in the Kentucky process require **ten (10) skill stations** to be completed by the candidate for FF1 with 100% competency. FF2 testing will consist of **six (6) skill stations** with a required 100% competency. Hazardous Materials Operations PPE and Product Control (NFPA 472:2013 Chapters 5, 6.2 and 6.6) are required pre-requisites for firefighter certification. **Four (4) Haz Mat skill stations** will be offered on the same test day as FF2 for the benefit of those needing the required certification.

Candidates are now required to test FF2 skills with Haz Mat. Candidates needing ONLY Haz Mat Operations must test following an organized course of the subject matter OR a scheduled skills test session that consists of ALL Haz Mat Operations (NFPA 472:2013 Chap 5) Ops Product Control (NFPA 472:2013 Chap 6.6) and Haz Mat PPE (NFPA 472:2013 Chap 6.2)

Testing requires the use of PPE, therefore candidates for testing are required to bring full PPE and SCBA. Each test day will expose the candidate to potential IDLH atmospheres with live-fire scenarios, therefore all candidates MUST be clean shaven to the point that facial hair does NOT come between the face piece seal and the face.

Candidates may bring their own copy of all Kentucky FF1, FF2 and Haz Mat Operations skill sheets and/or a copy of the IFSTA Essentials of Firefighting to the testing site to use as reference material. Testing DOES NOT break for lunch, light snacks will be made available.

Due to current NFPA requirements for certification, candidates shall show competency in medical training. Candidates shall bring a copy of a current CPR-Pro card and current first aid, first responder, EMT or Paramedic certification. Failure to show proof of medical training does not prohibit the candidate from testing, just certifying.

Limoss Power Packs:

This recall involves Limoss AKKU-PACK rechargeable lithium ion battery power packs sold as accessories for Palliser, Flexsteel and Best Home Furnishing power recliners and lift chairs. They are used to power the chair when an electrical outlet is not available. "Limoss Li-ion Battery Pack," model number ZB-B1800, code MC 160 and dates codes of 11-0102011 through 6-14-2012 are printed on a white sticker on the side of the unit. Recalled battery power packs are black and measure 6 inches long by 3 inches wide.



Limoss has received two reports of the battery pack overheating, including one incident that resulted in undetermined fire damage. No injuries were reported.
